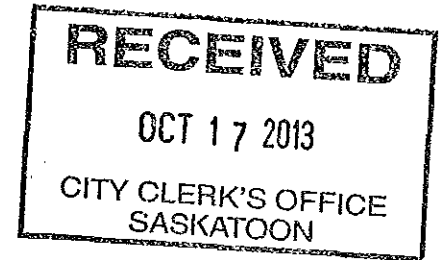

Our province and especially our city are in the midst of an unprecedented boom that has put a huge strain on the infrastructure and possibly the social fabric of our region. In some cases, the strain on the social fabric has been good. Not so much on the infrastructure.

Many businesses have been attracted to the boom conditions here in the city. There is a Darwinian rule of "survival of the most viable and best run" in the world of business economics. Businesses as a rule in Saskatoon are doing very well. My neighbor across the street runs a business in Saskatoon and has been doing renovations to his home. The

The losers in this boom is the middle class and the kids just out of high school/university who are trying to buy a home.

I hope council takes the time to listen to that middle class.

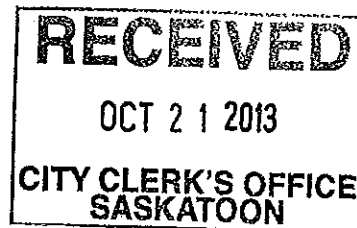

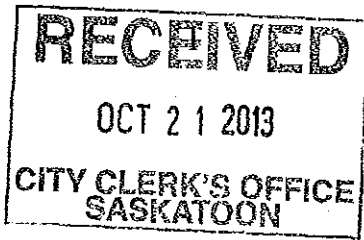

Re: Reallocation of Property Taxes

It just came to my attention at a social function this past weekend that the City will be considering on Monday night another reallocation of the property tax burden from commercial businesses to residents.

My first concern is why I am just hearing about this now. I am not aware of any advertising, consultation or seeking input from the residents.

My second concern is that high and rising house prices in Saskatoon already have placed a heavy burden on young and low income home residents. A further reallocation of taxes from businesses to home owners will increase this burden and push more people out of the opportunity to own a home. Is this a desirable outcome that Council is seeking?

The desire for increased competitiveness to attract business is a dangerous, slippery slope. It can be a race to the bottom. Where does it end? How much is enough? The City's analysis shows that we are already very attractive to business with a low ETR compared to Calgary, Edmonton and Winnipeg. We already have a competitive tax regime. Are businesses in Saskatoon hurting now? We are the fastest growing metropolitan area in Canada now. There is no compelling need to make us even more attractive to business at the expense of home owners.


I would encourage you to consult with City residents. Do not be trapped by the very well organized and financed business lobby. This is a narrow focus group that is motivated to decrease costs in order to increase profit, at the expense of home owners. We should be concerned with putting people first, not profits.

I encourage you to maintain the status quo. I encourage you to engage residents in this major initiative and start a consultation process. If you haven't received

much of a response, it is probably because most home owners are like me and did not even know such a thing was being considered.

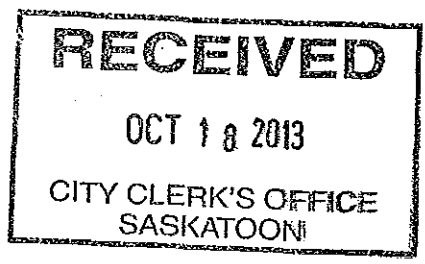

The recent decision by the A and F Committee to recommend to Council that the seasonal taxi plates be allocated by an open draw for drivers only, excluding taxi plate owners that drive their taxi, is extremely frustrating. We feel we have no choice but to speak bluntly at this point...

First let's discuss the open draw. We risk the draw winners going to the company that has the lowest standards.

Two companies have a 7 year old car rule; the third company allows cars up to 12 years old. That means you could buy a \$15000.00 car or a \$4000.00 car. Obviously the \$4000.00, 12 year old car would be much more attractive.

Two companies have a fleet color, the third does not. This is another feature that while financially attractive to the seasonal operator, lowers the standards of the City's entire taxi fleet.

One of the companies won't allow a taxi that has accident damage to operate. The other two companies don't take damaged taxis off the road for immediate repair, which is another lower standard.

Do we really want to have a situation where the lowest standards in our industry are the most attractive for seasonal plates?

We run the risk of the majority of the seasonal plates going to the company with the lowest standards or, just as big a problem, to the company that offers a deal that actually undercuts what a year round lease operator pays. This is unfair to year round operators that didn't win in the seasonal plate lottery. Also, if the majority of the plates go to one company, the regular year round operators will be hurt financially because of too many seasonal plates at one company. The companies not getting seasonal plates will lose market share which hurts the drivers.

Now the issue of owners operators being excluded from the seasonal plate draw. We are the people who have stayed in the industry and invested in the industry when the economics in Saskatoon were in the doldrums. We didn't just show up when our local economy started to boom and we won't be the people leaving when our economy eventually cools down.

The only difference between a driver who leases a plate and a driver who owns a plate is that the plate owner made a large capital investment in his business. The driver leasing his plate won't give it up if he wins a seasonal plate, because he wouldn't have employment when the seasonal period is over. He will either hire drivers to work on it or arrange to lease it out for the duration of the seasonal period. These are the same options an owner operator would have.

Owner operators are being penalized here and, given the years and money we have invested, it is an insult we don't take lightly.

When this taxi study and bylaw change process started, which the taxi industry certainly didn't ask for, the first thing changed was that our annual business license fee was increased from \$90.00 to \$375.00 per year. We were told that this was needed to cover costs your administration would have to set up a new taxi bylaw. Well, the administration has worked on this for a couple of years and the taxi companies have provided a lot of time working with administration to come up with recommendations for you to consider. For someone to think that all this work that we have paid for, and our collective knowledge and experience be tossed aside, is simply wrong.

For someone to think that they can come up with a better model for our industry, when they have never worked in it, and don't have a good understanding of all the nuances involved, is also simply wrong.

Your Administration presented you with recommendations we recognized as a good compromise, even though we disagree with the idea of an open draw. It's up to you to acknowledge this by accepting the work that has been done.
